Cease and Desist Letter regarding development in annexed areas of Santa Teresa RE:

PGST, et al. v. City of Sunland Park, et al., Case Nos.: A-1-CA-36279 and A-1-CA-36363

Dear Mayor Perea and Mr. Martinez:

This firm represents the Provisional Government of Santa Teresa and the purpose of this letter is to request that you cease and desist all activities related to permitting, development and improvements within the annexed areas of the Santa Teresa territory. This includes any and all past and future developments, including the cessation of any approval or processing any building permits or land use applications relying on the incorporation petition that was filed in 2016.

Please be advised that the recent ruling by the New Mexico Court of Appeals has found that "the district court had no basis by which to affirm the approval of Socorro Partner' annexation petition to Sunland Park" making the annexation of the area in dispute invalid. The Memorandum Opinion containing the most recent ruling entered on July 25, 2022 in PGST, et al. v. City of Sunland Park, et al., Case Nos.: A-1-CA-36279 and A-1-CA-36363 is attached for your review.

Based on this ruling, our clients are asserting their jurisdiction over the area in dispute and consider any and all approval of development activities by the City of Sunland Park to be invalid. We understand a Petition for Writ of Certiorari has been filed with the New Mexico Supreme Court, however in the absence of a ruling by the Court in the alternative, the Court of Appeals Opinion stands, and no action should be taken contrary to that ruling.

The areas of the proposed municipality of Santa Teresa are currently within the jurisdiction of Dona Ana County and all permits can only be issued in that area by the County. The Court of Appeals made clear that under the doctrine of prior jurisdiction, none of Sunland Park's annexations after the Incorporation Petition are valid.
